Registration fee

Payable by the parents of each pupil on acceptance of a place.

Tuition fees - collected by Exeter School

Senior School

£24,075 per annum (charged in 3 equal termly instalments of £8,025)

Junior School

£18,975 per annum (charged in 3 equal termly instalments of £6,325)

The cost of term time lunches is included within the fees. Fees are collected termly.

Sibling discounts: A reduction of 5% of the tuition fee will be made for the second child in respect of whom fees are being paid in the senior or junior school, and 10% for the third or subsequent child.

Due date

It is a condition of your contract with the school that all fees invoices must be paid by the first day of each term. For the academic year 2024/25 the due dates are therefore 5 September 2024, 6 January 2025 and 23 April 2025. In the event of late payment, the rate of interest charged will be at 1.5% per month accruing on a daily basis. This late payment charge will be added to subsequent invoices.

Extras

The tuition fees cover all normal expenses incurred by the school in the education of pupils.

Tuition fees do not include the charges for external examination, whether modular or linear. These are paid in advance by the school on behalf of the pupil and shown separately on fees invoices.

If a pupil is not performing in English at a level to enable them to achieve their potential in all subjects, then he/she will need to attend additional lessons in English which will be charged in addition to the school fee, and added to the termly invoice.

Notice

As set out in the school's *Terms and Conditions*, one full term's notice in writing is required before the withdrawal of a pupil from the school, otherwise a full term's fees in lieu of notice will be due.

Payment

Fees may be paid by direct transfer into the school's NatWest bank account. The account number is 00719722 and the sort code 56-00-49. The parent code, shown on the bill as a number, or your child's name must be quoted as the reference for this payment. Exeter School no longer accepts credit or debit cards for the payment of school fees.

Personal accident and dental insurance

This covers serious injury of a lasting nature occurring during term time or holidays as well as dental treatment arising as a result of a dental accident or emergency. This is included in the termly fees.

Homestay accommodation - collected by Gabbitas Education

Exeter School is a day school and as such does not have on site boarding accommodation. For our sixth form international pupils who are in the UK without their families we have experienced, and police checked homestay families, with whom they can live. Our homestay scheme is managed by Gabbitas Education (www.gabbitas.co.uk) who also act as guardians to our international pupils. We keep in regular contact with them all as their welfare and happiness with their host families is our top priority.

Homestay accommodation can be arranged for our sixth form pupils only. More information regarding the cost of this service is available on request.

BNO fees - Years 3 - 13

Applicants applying to Exeter School from Hong Kong as British National Overseas (BNO), who have been offered a place at Exeter School or Exeter Junior School, will be required to pay a refundable acceptance deposit equivalent to one term's fees in advance, and a one-off fee of £2,000. This covers the costs incurred by the school associated with using the BNO scheme, such as agent fees and additional English provision that may be required upon arrival. The day fee will be that applicable to the year group and not the overseas fees (see the Exeter School fees list for up to date fee information).

This one off fee will also be applicable to other applicants applying to the school via an agent, or those who are deemed in need of additional English provision.
